PROPERTY RULES AND REGULATIONS

I. AVAILABILITY

- A. The primary function of the building is to facilitate the needs of the CMRG Club, Inc Membership. Club sponsored events will take priority over members events. The building will be reserved on a first come, first served basis. Application for use should be submitted 30 days prior to scheduled event.
- B. ALL activities must be approved by the CMRG Club, Inc. Board of Directors, or Executive Committee.

II. REGULATIONS

- A. The use of the CMRG Club Inc., building and grounds is a privilege which carries responsibility. In addition to the rules of common courtesy, you are required to observe the following standards: no smoking in the building, no profanity, no running in the building, and **no use of personal alcoholic beverages is permitted.** PLEASE KEEP NOISE WITHIN A REASONABLE LEVEL.
- B. Energy conservation requires the turning out of all lights and the setting of all thermostats at 60 degrees when a group leaves. This includes checking inside and outside building lights and faucets in the washroom and kitchen. Please lock exterior doors. All exterior doors must be locked at the end of an activity.
- C. Maximum occupancy in the CMRG Club, Inc. building is 100 persons. This limit is set by the Fire Marshall and may not be exceeded.
- D. **Members are required to leave the facilities neat and clean. Clean stoves and ovens after use. All tables and chairs should be in place as they were found. ALL TRASH MUST BE REMOVED FROM THE BUILDING AND GROUNDS.**
- E. Damage to the building, equipment and/or grounds must be reported within twenty-four (24) hours to the CMRG Club, Inc., Grounds and Property Manager. The member is liable for any and all damage to the property above normal wear and tear. The CMRG Club, Inc. Board of Directors or Executive Committee will assess all damages made following an activity and will notify the user within two weeks following the club use. Payment for damages will be due within thirty (30) days following receipt of damage assessment notification.
- F. DO NOT ATTACH anything to walls, windows, doors, ceiling, trim, etc.
- G. Parking will only be allowed in designated areas.
- H. **All use of Firearms is strictly prohibited. (Hunting, Skeet and Trap Shooting is limited to approved membership activities)**

III. RESPONSIBILITY

- A. The responsible member shall be held responsible for the actions of all individuals in attendance. Also, the responsible member must ensure that attendees adhere to all of the above rules and regulations. Any damages will be the sole responsibility of the member.
- B. **No member should receive any financial benefit for CMRG Club Inc. use or events. Should it be determined that said member receive financial benefit for club use, said member will be immediately suspended from CMRG Club Inc, and may be subject to further action as directed by the CMRG Club, Inc. Board of Directors, or Executive Committee.**
- C. The CMRG Club, Inc. Board of Directors reserves the right to have its Representatives check for compliance with the terms and conditions of this club use agreement.
- D. The CMRG Club, Inc. Board of Directors reserves the right to **deny use of the property** at its discretion. Any matter not specifically covered by the regulations will be subject to the decision of the CMRG Club, Inc. Board of Directors.
